DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and WINKONSTRACT ENTERPRISES with office address at Unit 17, Filipiniana Complex, Calapan City, Oriental Mindoro represented by ENGR. LOUIGI ALMOND P. GAYUTIN, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Day Care Center at Panikian, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO HUNDRED NINETY TWO THOUSAND FIFTY TWO PESOS AND 42/100 ONLY (Php 292,052.42) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
