CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 20 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair/ Improvement of Road with Provision of Drainage Canal at Palayan St. Paclasan, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount EIGHT HUNDRED NINETY EIGHT THOUSAND PESOS AND 69/100 ONLY (Php 898,000.69) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
