CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 03 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 811 TRADING AND CONSTRUCTION with office address at 9 Palayan St., Paclasan, Roxas, Oriental Mindoro represented by ENGR. ARMIN C. SUZARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Riprap/ Slope Protection at Villa Pag-asa NHS, Bansud, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE HUNDRED NINETY SIX THOUSAND ONE HUNDRED EIGHTY FOUR PESOS AND 13/100 ONLY (Php 596,184.13) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
