Construction of Additional Second Phase of Multi-Purpose Building at OMNHS, Calapan City, Or. Mindro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF DRRP Fund 2021 intends to apply the sum of Five Hundred Seventy Nine Thousand Two Hundred Thirty Six Pesos and 68/100 Only (Php 579,236.68) being the approved Budget for the Contract (ABC) to payment under the contract for Construction of Additional Second Phase of Multi-Purpose Building at OMNHS, Calapan City, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Additional Second Phase of Multi-Purpose Building at OMNHS, Calapan City, Or. Mindoro". Completion of the Works is 28 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC.
