Construction of Multi-Purpose Building at OMNHS (Phase I), Calapan City, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund 2021 intends to apply the sum of Five Hundred Ninety Six Thousand Four Hundred Four Pesos and 64/100 Only (Php 596,404.64) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Multi-Purpose Building at OMNHS (Phase I), Calapan City, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Multi-Purpose Building at OMNHS (Phase I), Calapan City, Or. Mindoro". Completion of the Works is 29 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
