CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 21 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SGDG CONSTRUCTION AND SUPPLIES with office address Sapul, Calapan City, Oriental Mindoro represented by DEMETRIUS H. GOZAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi-Purpose Building at OMNHS (Phase 1), Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE HUNDRED NINETY FOUR THOUSAND NINE HUNDRED TWENTY SIX PESOS AND 72/100 ONLY (Php 594,926.72) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
