**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **LGSF-DRRP Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Drainage Canal at So. Catmon, Sumagui, Bansud, Oriental Mindoro (Construction of Canals: Source of Aggregate: Bongabong River Morente: Canal Station Limit: Section 1 0+000.00-0+113.00 Leftside; Section 2 0+000.00-0+070.00 Rightside; Canal Length=183.00m, Covered Canal Section 1 Sta. 0+050.00-Sta.0+113.00);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-498) in PhilGEPS Website on **November 01, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Drainage Canal at So. Catmon, Sumagui, Bansud, Oriental Mindoro (Construction of Canals: Source of Aggregate: Bongabong River Morente: Canal Station Limit: Section 1 0+000.00-0+113.00 Leftside; Section 2 0+000.00-0+070.00 Rightside; Canal Length=183.00m, Covered Canal Section 1 Sta. 0+050.00-Sta.0+113.00);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. 811 TRADING AND CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 10, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 10, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **811 TRADING AND CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **November 10, 2021** found out that bid price of **811 TRADING AND CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
