CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 03 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 811 TRADING AND CONSTRUCTION with office address at 9 Palayan St., Paclasan, Roxas, Oriental Mindoro represented by ENGR. ARMIN C. SUZARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Drainage Canal at So. Catmon, Sumagui, Bansud, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED SEVENTY SEVEN THOUSAND ONE HUNDRED TWELVE PESOS AND 38/100 ONLY (Php 977,112.38) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
