**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND  
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT  
(INFRASTRUCTURE)**

**Resolution No. 511, Series of 2021**

**WHEREAS**, there is an infrastructure project funded through the **20% Development Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Bacungan, Naujan, Oriental Mindoro (Concreting of Road: Station Limit 0+000.00-0+195.00; L of PCCP=195.00m, W of PCCP=3.00m, T of PCCP=0.23m, Thk. of 201=0.20m)**;

**WHEREAS**, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-500) in PhilGEPS Website on **November 01, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Road at Bacungan, Naujan, Oriental Mindoro (Concreting of Road: Station Limit 0+000.00-0+195.00; L of PCCP=195.00m, W of PCCP=3.00m, T of PCCP=0.23m, Thk. of 201=0.20m)**;

**WHEREAS**, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

**1. MDH CONSTRUCTION**

**WHEREAS**, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 10, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

**WHEREAS**, during the opening of Bid on **November 10, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

**WHEREAS**, the bid proposals submitted by **MDH CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
