CONTRACT AGREEMENT

THIS AGREEMENT, made this _______DEC _2 _0 _2021 ______ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and ADL CONSTRAK with office address at Bagumbayan, Roxas, Oriental Mindoro represented by ALEX D. LAQUI, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at So. Uyao, Bagumbayan, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED EIGHTY FOUR THOUSAND ONE PESOS AND 73/100 ONLY (Php 1,484,001.73) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
