**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

Resolution No. 514, Series of 2021

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Construction of Multi-Purpose Building at Sta. Cruz, Naujan, Oriental Mindoro (Construction of Covered Court w/ 26m x 14m dimension w/ installation of roof, roof framing and roof accessories; construction of slab (Class B); electrical works; painting works (Steel and Concrete); Rubberized Paint for Basketball Court Lines and Markings installation of fascia board and fascia cover; installation of gutter and downspout);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-504) in PhilGEPS Website on **October 29, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Construction of Multi-Purpose Building at Sta. Cruz, Naujan, Oriental Mindoro (Construction of Covered Court w/ 26m x 14m dimension w/ installation of roof, roof framing and roof accessories; construction of slab (Class B); electrical works; painting works (Steel and Concrete); Rubberized Paint for Basketball Court Lines and Markings installation of fascia board and fascia cover; installation of gutter and downspout);**

WHEREAS, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. DXB CONSTRUCTION**
- 2. LAS MINAS DE ORO CONSTRUCTION**

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **November 19, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **November 19, 2021** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

WHEREAS, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.

WHEREAS, the detailed evaluation and comparison of bids conducted on **November 19, 2021** found out that bid price of **DXB CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Lowest Calculated Bid**;
