CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 13 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. RECTO, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Women's Federation Building at Sta. Isabel, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION SEVEN HUNDRED EIGHTY TWO THOUSAND SIX HUNDRED THIRTY THREE PESOS AND 15/100 (Php 2,782,633.15) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
