TRIPARTITE CONTRACT AGREEMENT

THIS AGREEMENT, made this December 21, 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY," **WTL CONSTRUCTION** with office address Manila St., Mansalay, Oriental Mindoro represented by **RENATO T. DE LARA**, Proprietor, hereinafter called the "CONTRACTOR", and **DEPARTMENT OF HEALTH - CENTER FOR HEALTH DEVELOPMENT MIMAROPA**, a government agency created by virtue of Executive Order No. 292, Series of 1987, responsible for ensuring access to public health services to all Filipinos through the provision of quality health care and regulation of health goods and services, with office address at QMMC Compound, Project 5, Quezon City, herein represented by **DR. MARIO S. BAQUILOD, MPH, CESO IV**, in his capacity as OIC-Regional Director hereinafter called "PAYOR."


WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Repair/ Rehabilitation of Various Health Facilities in the Province of Oriental Mindoro damaged by Typhoon Tisoy at Pola, Pinamalayan & Mansalay, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION FIFTY TWO THOUSAND SEVENTY NINE PESOS AND 21/100 (Php 1,052,079.21)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
