3. All checks issued by DOH-CHD MIMAROPA representing payment of the amount to be paid shall be made payable to the CONTRACTOR who shall be named as "Payee" thereof, as hereinafter mentioned, the Contractor hereby covenants with the Entity and DOH-CHD MIMAROPA to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The DOH-CHD MIMAROPA hereby covenants to PAY the CONTRACTOR through PROGRESS BILLING, in consideration of the execution and completion of the Works and the remedying of defects wherein, the Entity, through the Provincial Engineer's Office (PEO) shall endorse to DOH-CHD MIMAROPA the said progress billing upon checking and monitoring upon actual completion of the infrastructure project or a specific portion, segment, or phase thereof of the Contractor, and undertake the corresponding request for progress payment for work accomplished; the Contract Price, or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
