DEC 1 0 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SGDG CONSTRUCTION AND SUPPLIES with office address Sapul, Calapan City, Oriental Mindoro represented by DEMETRIUS H. GOZAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Open Canal at So. Centro, Quinabigan, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FOUR MILLION THREE HUNDRED FORTY NINE THOUSAND SIXTY SEVEN PESOS AND 79/100 ONLY (Php 4,349,067.79) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
