CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 1 0 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter the "ENTITY" and GEMWEALTH CONSTRUCTION AND CORPORATION with office address at Lapu-lapu, Ibaan, Batangas represented by CLYDE E. SOTTO, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro. hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED NINETY SIX THOUSAND EIGHTY EIGHT PESOS AND 82/100 ONLY (Php 1,996,088.82) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
