CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 10 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **GEMWEALTH CONSTRUCTION AND TRADING CORPORATION** with office address at Lapu-lapu, Ibaan, Batangas represented by **CLYDE E. SOTTO**, the Authorized Managing Officer, hereinafter called the "CONTRACTOR".

**WHEREAS**, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Legislative Building at Poblacion, San Teodoro, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION NINE HUNDRED NINETY SIX THOUSAND EIGHTY EIGHT PESOS AND 82/100 ONLY (Php 1,996,088.82)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
