DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RGDG CONSTRUCTION with office address at 148 Diamond St., Bernabe Subdivision, Phase I, Paraňaque City, Metro Manila represented by RIC R. GUMAPAC, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Gabion at Sto. Domingo (Lapog), Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION FOUR HUNDRED NINETY TWO THOUSAND FIVE HUNDRED EIGHTY FIVE PESOS AND 23/100 ONLY (Php 1,492,585.23) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
