# Construction of Drainage Canal with Cover both sides at So. Dillaresis, Bagumbayan, Roxas, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2021 intends to apply the sum of Two Million Two Hundred Forty Thousand Eight Hundred Seventeen Pesos and 69/100 Only (Php 2,240,817.69) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Drainage Canal with Cover both sides at So. Dillaresis, Bagumbayan, Roxas, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Drainage Canal with Cover both sides at So. Dillaresis, Bagumbayan, Roxas, Oriental Mindoro". Completion of the Works is 33 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
