**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the LGSF-DRRP Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of 2 CL in Naujan Municipal HS, Bacungan Extension, Naujan, Oriental Mindoro/ Repair of 2 CL in Mabini ES – Annex, Naujan, Oriental Mindoro/ Repair of 2 CL in Laguna HS, Naujan, Oriental Mindoro (Removal and replacement of roofing for both classrooms. Additional elevation of both classrooms. Construction of beams for both CLs. Construction of gable wall at Grade 7A classroom./ Installation of roof at bldg. 5 room 2. Installation of ceiling at 2 CLs (inside only) & roof accessories (fascia cover at gable only & fascia board at whole building. Extension of eaves at front for bldg. 5 room 1 (0.3m) / Replacement of ceiling for 2 CLs (inside only). Construction of wall divider at Grade 7 Rose CL. Replacement of roof sheets and flashing at 2 CLs.);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-517-A) in PhilGEPS Website on **November 26, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of 2 CL in Naujan Municipal HS, Bacungan Extension, Naujan, Oriental Mindoro/ Repair of 2 CL in Mabini ES – Annex, Naujan, Oriental Mindoro/ Repair of 2 CL in Laguna HS, Naujan, Oriental Mindoro (Removal and replacement of roofing for both classrooms. Additional elevation of both classrooms. Construction of beams for both CLs. Construction of gable wall at Grade 7A classroom./ Installation of roof at bldg. 5 room 2. Installation of ceiling at 2 CLs (inside only) & roof accessories (fascia cover at gable only & fascia board at whole building. Extension of eaves at front for bldg. 5 room 1 (0.3m) / Replacement of ceiling for 2 CLs (inside only). Construction of wall divider at Grade 7 Rose CL. Replacement of roof sheets and flashing at 2 CLs.);**

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. DXB CONSTRUCTION

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **December 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **DXB CONSTRUCTION** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:
