CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 21 2022 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and DXB CONSTRUCTION with office address at Bayabas St., Lalud, Calapan City, Oriental Mindoro represented by ENGR. EMILIA S. FAMPULME, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of 2 CL in Naujan Municipal HS, Bacungan Extension, Naujan, Oriental Mindoro / Repair of 2CL in Mabini ES- Annex, Naujan, Oriental Mindoro / Repair of 2 CL in Laguna HS, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION ONE HUNDRED NINETY SEVEN THOUSAND NINE HUNDRED PESOS ONLY (Php 1,197,900.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
