Construction of Bahay Kalinga at Pola, Oriental Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund 2021 intends to apply the sum of Two Million Nine Hundred Eighty Nine thousand One Hundred Thirty Pesos and 96/100 Only (Php 2,989,130.96) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Bahay Kalinga at Pola, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Bahay Kalinga at Pola, Oriental Mindoro". Completion of the Works is 111 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
