CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 10 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and DK CONSTRUCTION with office address at Barcenaga, Naujan, Oriental Mindoro represented by REGINO C. EVANGELISTA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of 4 CL in Joaquin G. Hernandez ES, Naujan, Oriental Mindoro and Repair of 2 CL in Sampaguita ES, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION ONE HUNDRED SEVENTY FOUR THOUSAND THREE HUNDRED SIX PESOS AND 95/100 ONLY (Php 1,174,306.95) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
