DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and MARCPHIL CONSTRUCTION with office address at San Aquilino, Roxas, Oriental Mindoro represented by MARCIANO M. DIMAPILIS, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Land Development for the Capitol in the South at Bagumbayan Roxas, Oriental Mindoro. hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE MILLION NINE HUNDRED TWENTY TWO THOUSAND FOUR HUNDRED SIXTEEN PESOS ONLY (Php 9,922,416.00) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
