Land Development for the Capitol in the South at Bagumbayan, Roxas, Or. Mindoro

1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund CA 2019 intends to apply the sum of **Nine Million Nine Hundred Thirty Two Thousand Four Hundred Seventy Seven Pesos and 98/100 Only (Php 9,932,477.98)** being the approved Budget for the Contract (ABC) to payment under the contract for “**Land Development for the Capitol in the South at Bagumbayan, Roxas, Or. Mindoro**”. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for “**Land Development for the Capitol in the South at Bagumbayan, Roxas, Or. Mindoro**”. Completion of the Works is **122 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
