# BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) AND RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT (INFRASTRUCTURE)

## Resolution No. 557, Series of 2021

WHEREAS, there is an infrastructure project funded through the 20% Development Fund 2021 to be undertaken by the Provincial Government of Oriental Mindoro for the Improvement of Multi-Purpose Building at San Isidro, Victoria, Oriental Mindoro (Construction/Improvement of 5.60m x 5.00m Two (2) Storey Multi-Purpose Building);

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-524) in PhilGEPS Website on November 10, 2021 and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the Improvement of Multi-Purpose Building at San Isidro, Victoria, Oriental Mindoro (Construction/Improvement of 5.60m x 5.00m Two (2) Storey Multi-Purpose Building);

WHEREAS, in response to the said advertisement, two (2) prospective bidders/contractors submitted application for eligibility and purchased bid documents;

- 1. TWENTY SIXTEEN CONSTRUCTION & GENERAL MERCHANDISE
- 2. RJJJ ENGINEERING SERVICES

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on December 01, 2021, the bids were received until 8:30 am and opened thereafter in accordance with the provisions of R.A. 9184 otherwise known as "Government Procurement Reform Act and its Implementing Rules and Regulations";

**WHEREAS**, during the opening of Bid on **December 01**, **2021** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

**WHEREAS**, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.
