CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 22 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and TWENTY SIXTEEN CONSTRUCTION & GENERAL MERCHANDISE with office address at San Isidro, Victoria, Oriental Mindoro represented by RICHARD V. INCIONG, Authorized Managing Officer, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Improvement of Multi- Purpose Building at San Isidro, Victoria, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED NINETY FOUR THOUSAND TWO HUNDRED THIRTY THREE PESOS AND 26/100 ONLY (Php 1,994,233.26) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
