CONTRACT AGREEMENT



DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RJJJ ENGINEERING SERVICES with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by JOHN CROMWELL D. **RECTO**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road Gap at Brgy. Laguna, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY THOUSAND FOUR HUNDRED EIGHTY FOUR PESOS AND 16/100 (Php 990,484.16) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
