Construction of Open Canal at So, Piñahan-Manggahan, Maliancog, Pinamalayan, Or. Mindoro

1. The Provincial Government of Oriental Mindoro (PGOM) through the 5% LDRRM Fund 2021 intends to apply the sum of **Two Million One Hundred Sixty Eight Thousand Nine Hundred Ninety Five Pesos and 63/100 Only (Php 2,168,995.63)** being the approved Budget for the Contract (ABC) to payment under the contract for **“Construction of Open Canal at So. Piñahan-Manggahan, Maliancog, Pinamalayan, Or. Mindoro”**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PGOM now invites bids for **“Construction of Open Canal at So. Piñahan-Manggahan, Maliancog, Pinamalayan, Or. Mindoro”**. Completion of the Works is **41 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
