Construction of Provincial BHW Center (Phase II) at Sta, Isabel, Calapan City, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the LGSF DRRP Fund 2021 intends to apply the sum of One Million Three Hundred Ninety Eight Thousand Five Hundred Seventy Two Pesos and 60/100 Only (Php 1,398,572.60) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Provincial BHW Center (Phase II) at Sta. Isabel, Calapan City, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Provincial BHW Center (Phase II) at Sta. Isabel, Calapan City, Or. Mindoro". Completion of the Works is 65 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
