CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 2 1 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SGDG CONSTRUCTION AND SUPPLIES with office address Sapul, Calapan City, Oriental Mindoro represented by DEMETRIUS H. GOZAR, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road with Box Culvert at Guinhawa, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED ONE THOUSAND EIGHT HUNDRED FIFTY THREE PESOS AND 27/100 ONLY (Php 1,901,853.27) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
