Concreting of Road with Box Culvert at Guinhawa, Pinamalayan, Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 20% Development Fund 2021 intends to apply the sum of One Million Nine Hundred Four Thousand Six Hundred Sixty four Pesos and 80/100 Only (Php 1,904,664.80) being the approved Budget for the Contract (ABC) to payment under the contract for "Concreting of Road with Box Culvert at Guinhawa, Pinamalayan, Or. Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Concreting of Road with Box Culvert at Guinhawa, Pinamalayan, Or. Mindoro". Completion of the Works is 57 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
