**Construction of Provincial Federation BHW Center at Calapan City, Or. Mindoro**

1. The Provincial Government of Oriental Mindoro (PGOM) through the General Fund 2021 intends to apply the sum of **One Million Three Hundred Ninety Seven Thousand Five Hundred Forty One Pesos and 68/00 Only (Php 1,397,541.68)** being the approved Budget for the Contract (ABC) to payment under the contract for “Construction of Provincial Federation BHW at Center at Calapan City, Or. Mindoro”. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PGOM now invites bids for “Construction of Provincial Federation BHW at Center at Calapan City, Or. Mindoro”. Completion of the Works is **43 calendar days**. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
