ARMIN C. SUZARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Repair of Covered Court at Fe Del Mundo High School, B. Del Mundo, Mansalay, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED SIXTY SIX THOUSAND FIFTY PESOS AND 77/100 ONLY (Php 966,050.77) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
