CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 20 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **RADEL CONSTRUCTION** with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by **ENGR. ADELFA P. PEREZ**, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Completion of Barangay Hall at Brgy. Pagkakaisa, Naujan, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **FIVE HUNDRED NINETY SEVEN THOUSAND EIGHT HUNDRED EIGHTY ONE PESOS AND 32/100 ONLY (Php 597,881.32)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
