DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Completion of Barangay Hall at Brgy. Pagkakaisa, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount FIVE HUNDRED NINETY SEVEN THOUSAND EIGHT HUNDRED EIGHTY ONE PESOS AND 32/100 ONLY (Php 597,881.32) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
