DEC 2 0 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and LAS MINAS DE ORO CONSTRUCTION with office address in Sta. Maria Village, Calapan City, Oriental Mindoro represented by EVELYN A. ABAS, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Rehabilitation of Drainage Canal at Suqui, Calapan City, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY FOUR THOUSAND NINE HUNDRED THIRTY FIVE PESOS AND 39/100 ONLY (Php 994,935.39) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
