CONTRACT AGREEMENT

THIS AGREEMENT, made this ________ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SOSEP BUILDERS with office address at Campaasan, Bulalacao, Oriental Mindoro represented by ENGR. ERNESTO C. VILLAS, JR., Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Water System at Brgy. Happy Valley, Socorro, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount NINE HUNDRED NINETY SIX THOUSAND SEVEN HUNDRED EIGHTY FIVE PESOS AND 82/100 ONLY (Php 996,785.82) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - E. Credit Line or Net Financial Contracting Capacity.
 - F. PERT/CPM Diagram and bar chart with S-curve.
 - G. Other documentary requirements
 - 1. Equipment Utilization Schedule
 - 2. Manpower Utilization Schedule
 - 3. Construction Method
 - 4. Construction Schedule and S-Curve
