**BAC RESOLUTION DECLARING SINGLE CALCULATED RESPONSIVE BID (SCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **Special Education Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Repair of Makeshift Building at Bukal Elementary School, Bongabong, Oriental Mindoro and Construction of Main Gate at Maliancog ES, Maliancog, Pinamalayan, Oriental Mindoro (Repair of Makeshift Building; Repair of Roof Framing and Roofing, Doors, & Windows, Ceiling and Tileworks, Repainting of Building/ Construction of Arch with Gate)**;

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-541-A) in PhilGEPS Website on **December 08, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Repair of Makeshift Building at Bukal Elementary School, Bongabong, Oriental Mindoro and Construction of Main Gate at Maliancog ES, Maliancog, Pinamalayan, Oriental Mindoro (Repair of Makeshift Building; Repair of Roof Framing and Roofing, Doors, & Windows, Ceiling and Tileworks, Repainting of Building/ Construction of Arch with Gate)**;

WHEREAS, in response to the said advertisement, **one (1) prospective bidder/contractor** submitted application for eligibility and purchased bid documents;

1. SOSEP BUILDERS

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 29, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **December 29, 2021** eligibility check was conducted to one bidder/contractor mentioned above and were found eligible by the BAC;

WHEREAS, the bid proposals submitted by **SOSEP BUILDERS** was examined and found substantially complied with the technical and financial proposals, thereby making the bid proposals passed the preliminary examination of bid as the bid price read out as:

WHEREAS, the detailed evaluation of bids conducted on **December 29, 2021** found out that bid price of **SOSEP BUILDERS** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Single Calculated Bid**;
