## CONTRACT AGREEMENT

DEC 2 9 2021 THIS AGREEMENT, made this between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RGDG CONSTRUCTION with office address at 148 Diamond St., Bernabe Subdivision, Phase I, Paraňaque City, Metro Manila represented by RIC R. **GUMAPAC**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Protection Dike at Batuhan, Pola, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION FOUR** HUNDRED NINETY SEVEN THOUSAND THREE HUNDRED FORTY THREE PESOS AND 31/100 ONLY (Php 1,497,343.31) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
