CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 29 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **RGDG CONSTRUCTION** with office address at 148 Diamond St., Bernabe Subdivision, Phase I, Parañaque City, Metro Manila represented by **RIC R. GUMAPAC**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Protection Dike at Batuhan, Pola, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION FOUR HUNDRED NINETY SEVEN THOUSAND THREE HUNDRED FORTY THREE PESOS AND 31/100 ONLY (Php 1,497,343.31)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
