CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 28 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and 811 TRADING AND CONSTRUCTION with office address at 9 Palayan St., Paclasan, Roxas, Oriental Mindoro represented by ENGR. ARMIN C. SUZARA, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Slope Protection at Manihala, Bansud, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION ONE HUNDRED EIGHTY FOUR THOUSAND THREE HUNDRED SEVENTY EIGHT PESOS AND 19/100 ONLY (Php 1,184,378.19) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
