**BAC RESOLUTION DECLARING LOWEST CALCULATED RESPONSIVE BID (LCRB) AND
RECOMMENDING APPROVAL OF AWARD OF THE CONTRACT
(INFRASTRUCTURE)**

WHEREAS, there is an infrastructure project funded through the **20% Development Fund 2021** to be undertaken by the Provincial Government of Oriental Mindoro for the **Concreting of Road at Poblacion, Oriental Mindoro (Concreting of Road: Source of Aggregates: Mayabig River; Station Limit 0+000.00-0+164; L of PCCP=164.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk. of 201=0.20m, Crossdrain Section: Sta. 0+020.00 RCPC 610mm dia. Crossdrain Section: Sta. 0+117.00 Box Culvert Type; Total Length=164.00m);**

WHEREAS, the Provincial Government of Oriental Mindoro thru its Bids and Awards Committee advertised the Notice of Invitation to Bid (IB No. CW-2021-546) in PhilGEPS Website on **November 19, 2021** and posted in the Provincial Capitol Complex, Bulletin Board, Camilmil, Calapan City on even date for the **Concreting of Road at Poblacion, Oriental Mindoro (Concreting of Road: Source of Aggregates: Mayabig River; Station Limit 0+000.00-0+164; L of PCCP=164.00m, W of PCCP=4.00m, T of PCCP=0.23m, Thk. of 201=0.20m, Crossdrain Section: Sta. 0+020.00 RCPC 610mm dia. Crossdrain Section: Sta. 0+117.00 Box Culvert Type; Total Length=164.00m);**

WHEREAS, in response to the said advertisement, **two (2) prospective bidders/contractors** submitted application for eligibility and purchased bid documents;

- 1. RADEL CONSTRUCTION**
- 2. RJJJ ENGINEERING SERVICES**

WHEREAS, the opening of bid was held at BAC Office, Provincial Capitol Complex, Calapan City on **December 10, 2021**, the bids were received until **8:30 am** and opened thereafter in accordance with the provisions of **R.A. 9184** otherwise known as "**Government Procurement Reform Act and its Implementing Rules and Regulations**";

WHEREAS, during the opening of Bid on **December 10, 2021** eligibility check was conducted to two (2) bidders/contractors mentioned above and were found eligible by the BAC;

WHEREAS, all bid proposals submitted during the opening of bid were examined and found substantially complied with the technical and financial proposals, thereby making all bid proposals passed the preliminary examination of bid as their corresponding bid price read out as follows.

WHEREAS, the detailed evaluation and comparison of bids conducted on **December 10, 2021** found out that bid price of **RADEL CONSTRUCTION** is deemed the most advantageous to the government and no minor arithmetic correction has been made and therefore, found to be the **Lowest Calculated Bid**;
