DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and RADEL CONSTRUCTION with office address along C-5 Road, Sta. Isabel, Calapan City, Oriental Mindoro represented by ENGR. ADELFA P. PEREZ, Proprietress, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Concreting of Road at Poblacion, Puerto Galera, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED EIGHTY FIVE THOUSAND FOUR HUNDRED THIRTY THREE PESOS AND 07/100 ONLY (Php 1,985,433.07) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
