CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 28 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **SGDG CONSTRUCTION AND SUPPLIES** with office address Sapul, Calapan City, Oriental Mindoro represented by **DEMETRIUS H. GOZAR**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Construction of Protection Dike at Wawa, Pinamalayan, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION FOUR HUNDRED EIGHTY SIX THOUSAND NINETY NINE PESOS AND 06/100 ONLY (Php 1,486,099.06)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
