
## CONTRACT AGREEMENT

THIS AGREEMENT, made this \_\_\_\_\_\_\_ between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and SHANLEY CONSTRUCTION with office address at Carreon St. Centro East, Santiago City, Isabela represented by PATRICK A. TAGUINOD, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Drainage Canal at So. Eucalyptus, Zone III, Pinamalayan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount TWO MILLION TWO HUNDRED TWENTY FOUR THOUSAND SEVEN HUNDRED FIFTY NINE PESOS AND 11/100 ONLY (Php 2,224,759.11) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
