## Construction of Drainage Canal at So. Eucalyptus, Zone III, Pinamalayan Or. Mindoro

- 1. The Provincial Government of Oriental Mindoro (PGOM) through the 5% LDRRM Fund 2021 intends to apply the sum of Two Million Two Hundred Twenty Nine Thousand Two Hundred Ten Pesos and 19/100 Only (Php 2,229,210.19) being the approved Budget for the Contract (ABC) to payment under the contract for "Construction of Drainage Canal at So. Eucalyptus, Zone III, Pinamalayan, Oriental Mindoro". Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PGOM now invites bids for "Construction of Drainage Canal at So. Eucalyptus, Zone III, Pinamalayan, Oriental Mindoro". Completion of the Works is 33 calendar days. Bidders should have completed within five (5) years before the date of submission and receipt of bids, a single completed contract similar to the Project worth at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
