CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 29 2021 between PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO, Camilmil, Calapan City, Oriental Mindoro, represented by HUMERLITO A. DOLOR, MPA, Ph.D., Provincial Governor hereinafter called the "ENTITY" and KASANGA CONSTRUCTION AND SUPPLIES with office address at Bayanan I, Calapan City, Oriental Mindoro represented by ROMEL B. DEINLA, General Manager, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Construction of Multi-Purpose Building at Balite, Naujan, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount ONE MILLION NINE HUNDRED SEVENTY EIGHT THOUSAND FOUR HUNDRED TEN PESOS AND 42/100 ONLY (Php 1,978,410.42) by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
