CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 28 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **876 CONSTRUCTION & SUPPLY** with office address at Malamig, Calapan City, Oriental Mindoro represented by **ROBERTO B. YLAGAN**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the **Completion of Multi-Purpose Building at Sta. Maria, Gloria, Oriental Mindoro**, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **ONE MILLION FOUR HUNDRED NINETY TWO THOUSAND ONE HUNDRED SIXTY FOUR PESOS AND 80/100 ONLY (Php 1,492,164.80)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
