CONTRACT AGREEMENT

THIS AGREEMENT, made this DEC 31 2021 between **PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO**, Camilmil, Calapan City, Oriental Mindoro, represented by **HUMERLITO A. DOLOR, MPA, Ph.D.**, Provincial Governor hereinafter called the "ENTITY" and **RJJJ ENGINEERING SERVICES** with office address 030 Purok I, Brgy. San Agustin I, Naujan, Oriental Mindoro represented by **JOHN CROMWELL D. RECTO**, Proprietor, hereinafter called the "CONTRACTOR".

WHEREAS, the ENTITY is desirous that the CONTRACTOR execute the Installation of one (1) Unit Deep Well at Buhangin, Naujan, Oriental Mindoro / Installation of Free Flow at Panikian, Naujan, Oriental Mindoro / Installation of Free Flow at Brgy. Aurora, Naujan, Oriental Mindoro / Installation of 7 Free Flow at Motoderazo, Naujan, Oriental Mindoro / Installation of Free flow at So. Purok 2 & 4, Malad, Calapan City, Oriental Mindoro / Installation of Free Flow at So. Tahik, Patas, Calapan City, Oriental Mindoro / Installation of 2 units Free Flow at Sta. Rita, Calapan City, Oriental Mindoro / Installation of 3 units Free Flow at San Jose, Roxas, Oriental Mindoro, hereinafter called the "WORKS", and the ENTITY has accepted the Bid for the amount **TWO MILLION NINE HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED TWENTY SEVEN PESOS AND 61/100 (Php 2,918,527.61)** by the CONTRACTOR for the execution and completion of such Works and the remedying of any defects therein.
